Hereinafter "Robot Consulting"), a software development company using AI technology, has raised a total of 450 million JPY through third-party allotment of new shares to Stella MIC Investment Ltd. (overseas fund), FTG Company Corporation, Angel Box (venture capital), and private investors in Japan and overseas. We are pleased to report that the total amount raised has now exceeded 500 million JPY.

Robot Consulting has crossed technology and the professional services industry to develop the service launch of "Lawyer Robot", an AI digital law service, and "Labor Robot", an HR and labor management, HR evaluation, and grant application system.

Our goal is to develop these services that can improve the work efficiency of law and labor offices, and also to help the general public have a better life.

Lawyers have a strong image as strict law-keepers, but there is still a high threshold for the general public to casually consult with them. We will provide "Lawyer Robot" as a service to make lawyers more accessible to the general public and to improve the business efficiency of law firms.

The system is being launched at the "Osaka Smartcity Partners Forum", which was established in cooperation with Osaka Prefecture, 43 municipalities, companies, universities, and civic tech companies to promote the realization of an "Osaka Model" smart city.

As a service for law offices, we are developing a system in which AI learns data from tens of thousands of precedents to derive highly accurate answers. (Patent registration pending)

For Labor Robot, we are developing a system that enables HR evaluation and labor consulting, and in the future, we plan to introduce a system that enables automatic application for subsidies.

With this capital funding increase, we intend to develop a system and build a global law and labor system on metaverse, including overseas expansion, and promote efforts to eliminate problems in law and labor.
